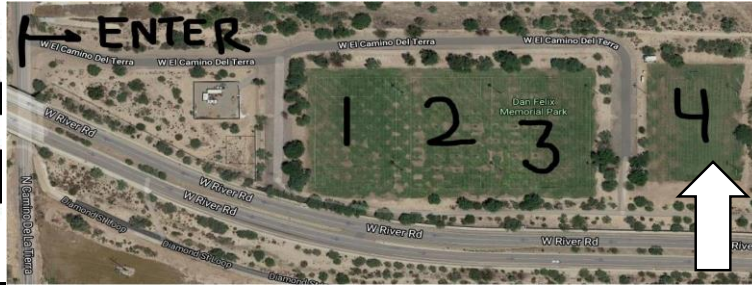

FOR GAMES, START TIMES BETWEEN GAMES WILL BE GIVEN ADDITIONAL TIME TO ALLOW FOR TEAM MEMBERS AND PARENTS TO LEAVE SITE PRIOR TO NEW TEAMS/PARENTS ARRIVING.

PLAYERS ARE NOT TO SHARE WATER OR SNACKS! EACH PLAYER MUST BRING THEIR OWN.

FOR GAMES, THERE WILL BE NO POST GAME HAND SHAKES.

ADDITIONAL MANDATES MAY BE ADDED AS WE MOVE THROUGH THE SEASON AND BASED UPON ADDITIONAL GOVERNMENT MANDATES THAT ARE ADDED.
